
...THAT THOSE WHO HAVE LESS WILL HAVE MORE!

"LOVE AND MERCY FUND DRIVE" LAUNCHED!

GEORGIA – Ancop Foundation USA (ANCOP USA) and Couples for Christ USA (CFCUSA) jointly launched late last month (April 2020) the LOVE & MERCY FUND DRIVE intended to help members of CFC USA who have fallen ill to Covid-19 and their families. It will also establish an emergency fund for CFC USA and ANCOP USA for use in similar exigencies in the future.

USA has the most number of confirmed Covid-19 cases, which as reported on May 25, 2020 by the US Centers for Disease Control and Prevention (CDC), stands at 1.6 million cases, with 97,049 deaths.

Within CFC USA, when the Fund Drive was launched in April, there were 20 confirmed cases among CFC members, with 2 deaths. As of this writing, the number has gone up considerably to 85 members, 6 of whom had died. Including those who are either PUIs or PUMs, the total number of CFC members and their family members who have either contracted Covid-19 or are PUIs/PUMs is 93.



There are 9 CFC regions which have reported Covid-19 cases among their members. The specific CFC areas with their numbers are:



Norby Perrin, CFC USA's Servant National, requests CFC Regional Heads and Area Heads to advise the CFC Home Office about any Covid-19 cases in their respective places involving CFC members or their immediate family members living with them, so prayers can be lifted up for them by the community and appropriate material assistance can be provided.

The CFC members of course will have to expressly agree that their names are sent to the CFC Home Office. CFC USA has circulated guidelines to follow for reporting Covid-19 cases to the CFC Home Office.

CFC members and Ancop supporters are encouraged to contribute to the Love & Mercy Fund. An update will be released next on the amount of funds generated by the campaign and the uses or distribution. Tax-deductible donations can be made either to Ancop USA through its bank account (see attached flyer) or to CFC USA through the Faith Direct app.

NEW ANCOP USA OFFICERS ANNOUNCED

NEW JERSEY - In a recent internal memorandum, Toffee Jeturian, Chairman, ANCOP Foundation USA (ANCOP USA), announced the election of new officers of the Foundation. Elected officers are Jose (Jojo) Reandalar as President and Victor (Vic) Lladoc as Corporate Secretary.

Reandalar replaces Roger Santos, who has devotedly served ANCOP USA for many years, has been designated as Couples for Christ (CFC) Regional Coordinator for Central America and will be focusing his efforts on growing the ministry in the region. Santos congratulated the new officers and wished them "the best in the service of the Lord". He said he is "thankful and full of gratitude to GOD for being given the opportunity to serve ANCOP USA".

Reandalar expressed his gratitude to the ANCOP USA Board and praised Santos for his "truly dedicated and selfless service in Ancop". He described Santos' efforts to grow Ancop as "truly inspiring" and wished that the loving GOD continually bless Santos and his family and his new mission work in Central America for CFC.

Reandalar has been with CFC for 25 years (started in 1995 in the Philippines) and currently is a member of the CFC USA National Council, overseeing ANCOP and the Catholic Church Relations Office (CCRO). Previously he was Overseer of CFC USA Family Ministries and Area Head of CFC New York. A lawyer-CPA by profession, Reandalar was previously Global Director, Marketing Compliance of Colgate-Palmolive Company in New York and practiced his accounting profession in the Philippines with the country's leading accounting firm, Sycip, Gorres, Velayo (SGV) & Co.

Vic Lladoc has been with CFC for 29 years (also started in the Philippines in 1991) and currently is Cluster Head of CFC North California and a member of the National Core Group of the Servants of the Lord (SOLD) Ministry. He is also the current Senior VP Legal & Compliance of Ancop USA, which complements his new role as Corporate Secretary. On the secular side, he currently works with California's Department of Industrial relations - Division of Workers' Compensation and does consulting service on the side. Jeturian, in his Memo, also thanked Santos for his service acknowledging that the latter had "tirelessly worked with ANCOP USA for many years" and "was instrumental in bringing ANCOP USA to where it is now."
